#### ADDENDUM #1

## WTP-18-01 VINE STREET WTP ACCELATOR IMPROVEMENTS

In order to clarify the intent of the Specifications and Drawings, the following provisions are provided and shall be considered part of the contract documents.

In order to ensure that all bidders are aware of these provisions, each bidder shall sign this addendum below and attach it to the proposal.

IMPORTANT: Failure to include a signed Addendum could result in the disqualification of your bid.

## **BID OPENING DATE AND TIME AND LOCATION:**

The bid opening has been rescheduled for **Thursday, May 9, 2019, at 2:00 p.m.** The location has been changed from the **Calapooia Room to the Periwinkle Room** at City Hall, 333 Broadalbin Street SW, Albany, OR 97321. Dropoff location for bids is unchanged.

#### **CONSTRUCTION DRAWINGS:**

Sheet G03 was amended to clarify some dimensions.

Drawing G06: The inside of the cone shall be prepared and coated. All surfaces above the deck plate as shown in the attached shop drawing 90524-02-002 shall be coated.

#### **TECHNICAL SPECIFICATIONS:**

Specification 0990 2.04, E.1.b.- The Contractor may submit using SSPC SP-6 for exterior surface preparation on Accelator No. 2 provided this is acceptable to the coating supplier. Any additional material or preparation required by the supplier shall be at no additional cost to the City.

Specification 09900 2.01, A.1.a.2)- Change Carboguard 691 to Carboguard 891VOC.

Specification 09900 2.01,B.2.a.2)- Change Flexxide Elastomer to Sanitile 120 Bonding Primer applied at 2.0 to 4.0 mils DFT followed by Flexxide Elastomer.

## THE FOLLOWING ITEMS ARE CLARIFICATIONS BASED ON QUESTIONS RECEIVED:

The fence on the south side of Accelator No. 1 has removable sections between the posts. The Contractor may remove these sections while working on the exterior of the tank but must replace the sections during non-working hours. If the Contractor has an alternative method to secure the site, the Contractor may submit a plan for approval.

The City of Albany hereby extends an invitation to submit bids for:

**WTP-18-01, Vine Street WTP Accelator Improvements**. This project will replace the existing tube settlers, clean and recoat the steel plate surfaces, and repair and coat concrete surfaces on the Accelators. The existing bridge and catwalk in Accelator 1 will be replaced, and an existing eight-inch valve will be replaced on Accelator 2.

An optional prebid meeting will be onsite at 300 Vine SW, Wednesday, May 1, 2019, at 10:30 AM.

Bids submitted shall be filed in sealed envelopes and received at the City of Albany Parks & Recreation counter, not later than 2:00 p.m., Tuesday, May 7, 2019 Thursday, May 9, 2019, addressed to the attention of Diane Murzynski, Purchasing Coordinator, at Albany City Hall, Finance Department, 333 Broadalbin Street SW, Albany, OR 97321. The outside of the envelopes shall plainly identify: (1) the Project name, (2) the Bid Opening time and date, (3) the Bidder's name, and (4) the Contractor's license number (per ORS 701). Immediately following the filing deadline, the bids shall be opened and publicly read in the Santiam Room of City Hall. Bid totals will be posted on the City's website at <a href="http://www.cityofalbany.net/departments/finance/city-purchasing/bids-rfps-rfgs">http://www.cityofalbany.net/departments/finance/city-purchasing/bids-rfps-rfgs</a>.

All City contracts contain a statement declaring that the bidder agrees to comply with the provisions of ORS 279C.800 through 279C.870 regarding payment of prevailing wages. The City's contract contains a clause which incorporates by reference all of the provisions of ORS Chapter 279C which are applicable to public contracts. Bidders are expected to be familiar with these provisions including, but not limited to, recent changes to ORS Chapter 279C.










SEE DWG D 90524.02-001 FOR GENERAL NOTES.
