## RESOLUTION NO.

A RESOLUTION ADOPTING THE ALBANY REVITALIZATION AGENCY (ARA) BUDGET FOR BIENNIUM 2025-2027

WHEREAS, the ARA budget review committee conducted a public meeting on the proposed BN 2025-2027 ARA budget on May 27, 2025; and

WHEREAS, the ARA budget review committee approved the BN 2025-2027 ARA budget May 27, 2025, with the approval of Resolution No. ARA 2025-1; and

WHEREAS, the ARA held a public hearing to receive any additional input on the approved BN 2025-27 budget on June 11, 2025,

NOW, THEREFORE, BE IT RESOLVED that the Albany Revitalization Agency hereby adopts the BN 2025-2027 approved budget in the amount of \$29,312,300; and

BE IT FURTHER RESOLVED that the amounts for the biennium beginning July 1, 2025, and for the purpose shown below are hereby appropriated as follows.

CARA Urban Renewal District	\$28,644,000
Special Payments	668,300
Total	\$29,312,300

BE IT FURTHER RESOLVED that the ARA budget committee hereby recommends that the ARA certify to the county assessors (Linn and Benton counties) a request for the ARA Plan Area for the maximum amount of revenue that may be raised by the division of taxes under section 1c, Article IX, of the Oregon Constitution and ORS Chapter 457 for each fiscal year of the biennium.
