Call to Order

Chair Frankie McCullough called the meeting to order at 5:30 p.m.

Roll Call

Members present: Chair Frankie McCullough, Vice-Chair Nolan Streitberger, Chuck Kratch, Alex Rice, Daniel Koenig, and Nichole Case

Approval of October 28, 2025, Minutes

5:30 p.m.

Daniel Koenig made a motion to approve the minutes as presented, Chuck Kratch seconded the motion, and the motion passed the commission 6-0.

Public Comment

5:32 p.m.

Brad Dennis shared concerns about the current lane markings at the intersection of Southwest Ellsworth and 9th Avenue. He believes there may be a safer way to mark the lanes. After discussion Civil Engineer I Andrew Monaco proposed to approach the Oregon Department of Transportation to see if they can explore alternative options.

Scheduled Business

5:44 p.m.

The commission invited Captain Buck Pearce with the Albany Police back to revisit the topic of lowering the speed limit on Ferry Street to 25 miles per hour after completing speed studies for the second time. After discussion the commission held a unanimous straw vote to have staff propose a residential district and lower the speed limit on Ferry Street to 25 miles per hour. Monaco agreed to discuss with staff and come back to the commission if staff was not in agreement.

Chair McCullough referred to a newspaper article by Hasso Herring regarding speed cameras and asked Captain Pearce for his opinion and feedback on the topic.

Citizen requests for additional stop signs in the Knox Butte neighborhood at Breezy Way and Windy Avenue were discussed. Staff proposed installing two-way stop signs at the intersections of Breezy Way, Windy Avenue, and Alameda Avenue. After discussion, Alex Rice moved to decline the request, Kratch seconded the motion, and the commission voted 6-0 to deny the request.

Business from the Commission

6:43 p.m.

In response to Kratch's request at the October meeting, the commission wrote a letter to the Albany City Council requesting that all fees from traffic cameras be dedicated to funding street maintenance, local public transit, and pedestrian and bicycle infrastructure. Koenig moved to sign the letter as presented, Rice seconded the motion, and the commission passed the motion with a 6-0 vote.
